Recommendation of the BOS members: -

1) The BOS members suggested introducing one-year Master of Law (LL.M.) program in specialization Alternate Dispute Resolution (ADR).

The six courses of 2 credit each can exclusively deal with subjects like Mediation/Conciliation/Arbitration/Negotiation/online dispute resolution (ODR) concerning disputes within India and cross border disputes. It was further resolved that in the upcoming 27th Board of Studies meeting, after a detailed discussion with the

Academician, Practicing Lawyers, and Firms working in the said field, a course outline be prepared.

- 2) The Dean School of Law informed the BOS members of the suggestions received from faculties of NMIMS SoL functioning in different States and discussion with VC for introducing "Zero" credit subjects of Local Legal / Administrative Language of the states where the NMIMS Schools of Law are situated. Accordingly, it is decided to introduce 15 hours per semester zero credit course from 1st to 4th year in Punjabi/Kannada/Hindi / Telugu/ Marathi. The course outlines will be prepared in consultation with experts and will be submitted for the approval of upcoming 27th Board of Studies meeting.
- 3) The subject Land Law has several state-based Laws; therefore, a note is added to the Course Outline of the program B.A., LL. B. (Hons) & B.B.A., LL. B. (Hons) for the subject Land Law Semester VII regarding method to be adopted for incorporating the relevant laws of the States where the SOL is situated. The law applicable in Maharashtra will be taught only if the concerned State does not have a corresponding Law.
- 4) It was also resolved that a note should be added in every course outline of Law subjects as follow:

"Note: - Latest updated Statutes/Acts/Rules & Regulations and Case Laws to be taught after discussion in Multi-campus Coordination Meeting."

The Board od Studies recommended that after due incorporations of the changes suggested by the learned Members, all Course Outlines and the other decisions approved during the BoS Meeting may be submitted to the Academic Council meeting for University's approval.

In conclusion, Dr. Durgambini Patel acknowledged the contributions of the learned BoS Members and thanked everyone.

The meeting ended with a *Vote of Thanks* by Dr Ravi Saxena.

- New Programme Learning Outcomes (PLOs) were introduced separately for B.A., LL.B. (Hons.) and B.B.A., LL.B. (Hons.) with a special focus on the six levels of Bloom's taxonomy. All syllabi will reflect the new PLO-CLO mapping for A.Y. 2024-25 onwards.
- Also, some of the syllabi of Term I, Semester I, III,V, VII and IX are updated with reading materials, ICA component are revised and Tutorial policy, and changes made within 20% for the batch – 2024-29, 2023-28, 2022-27, 2021-26 and 2020-25.
- The Tutorial Policy has been revised and updated with the following details from AY 2024-25
 - i) 7 out of 15 hours of Tutorials to be used for ICA Group Discussion (GD).
 - ii) The remaining 8 hours of tutorials will be used for the proposed tutorial plan given by the faculty.

Faculties need to plan tutorial sessions other than ICA- GD after consulting with the co-faculty members (Faculty teaching the same subject in other divisions) and multi-campus coordination.

The Tutorials will not be applicable to the i)Specialisation Course (2 Credits), ii) elective Course (2 Credits), iii) other 2 Credit Course, iv) all clinical papers, v) French (Non-credit Course), and vi) local languages.

- The course Structure for Batch 2023-28 is revised; below mentioned details were discussed in the BOS meeting and approved by the members.
- In the Course Structure for Batch 2023-28 semester VII (A.Y. 2026-27), the below mentioned elective Course were replaced with the existing elective Course, considering the availability of the faculties in the other school of law campuses.
 - i. Elective Course Maritime Law shifted from Semester VII to V for Batch 2023-28 from A.Y. 2025-26
 - ii. Elective Course Media and Entertainment Law shifted from Semester VIII to V for Batch 2023-28 from A.Y. 2025-26
 - iii. Elective Course Law and Technology shifted from Semester VII to VI for Batch 2023-28 from A.Y. 2025-26
 - iv. Elective Course Forensic Science and Law is shifted from Semester VI to VII for Batch 2023-28 from A.Y. 2026-27
 - v. Elective Course Election Law and Law relating to Customs & Customs Tariff are shifted from Semester VIII to VII for Batch 2023-28 from A.Y. 2026-27

- The KPMSOL shall be continuing with the two-credit elective course Maritime Law of Semester VII shifted to semester V of B.A., LL.B.(Hons) and B.B.A., LL.B.(Hons) for the Batch 2023-28 in 3rdth Year as the school is now well equipped with a faculty having specialisation in the Maritime Law.
- The KPMSOL shall be continuing with a Dissertation in 5th Year semester X B.A., LL.B.(Hons) and B.B.A., LL.B.(Hons) for the Batch 2023-28 onwards. In place of the "Zero Credit" internship course, Dissertation (Empirical Project) "Zero Credit" will be continued; the same will be evaluated out of 100 marks.
- The syllabus for Law of Crimes I: IPC, Semester III for Batch 2023-28, B.A., LL.B.(Hons) and B.B.A., LL.B.(Hons) (New Law "Bhartiya Nagarik Suraksha Sanhita") is revised noting that the new law may be adopted from July 2024; else, the previous syllabus would continue.

1. Syllabus is revised and approved by BOS members for the course Labour and Industrial Law I, semester VII, for the batch 2021-26 and applicable from the A.Y. 2024-25 onwards.

Master of Law (LL.M.) -

1. In one year Master of Law (LL.M.) program, two new specialisations introduced from the A.Y. 2024-25

a. Alternate Discourse Resolution (ADR):

The introduction of a new specialisation in ADR was discussed.

However, in semester II, the board members made suggestions to modify the course structure. Specifically, it was proposed that the Course of Mediation and Conciliation to be merged. Additionally, it was suggested that the subject of Dispute Settlement-Lok Adalat to be amended as a separate entity. The consideration of bilateral arbitration was also discussed.

The approval of a new specialisation in **Alternate Discourse Resolution** was confirmed. The proposed course structure and syllabus for the course of **Law of Arbitration** Semester I were discussed and approved unanimously.

b. International and Maritime Law:

The approval of a new specialisation in International and Maritime Law was confirmed. The proposed course structure and outline for the course International Law of The Sea, Semester I were discussed and approved unanimously.

2. Revision in the syllabi of two courses for AY 2024-25 for one course it is applicable to all specialization (Corporate Law/Intellectual Property Law/ Constitutional and Administrative Law /Criminal Laws/ Financial Regulations/Alternative Dispute Resolution & International and Maritime Law) & another subject only for Corporate Law specialization.

It was noted that two course syllabi had undergone minor changes in the past year:

- Competitive Public Law (All specialization)
- Mergers and Acquisitions (Corporate Law)

The changes were implemented in accordance with recent updates in Law.

The Board of Studies recommended that after due incorporations of the changes suggested by the learned Members, all Course Outlines and the other decisions approved during the BoS Meeting may be submitted to the Academic Council meeting for the University's approval.

In conclusion, Dr. Durgambini Patel acknowledged the contributions of the learned BoS Members and thanked everyone.

The meeting ended with a Vote of Thanks by Dr. Durgambini Patel.

A meeting was held online on 14th May 2024 at 2.00 p.m. to discuss the "Structure of 4 economic papers" with the Honourable Vice Chancellor, Dean KPMSOL, SOL (All Campuses) Associate Dean, and Economics faculty of all campuses.

Dr.Durgambini, Dean, KPMSOL, welcomed all the members and requested them to give feedback on the 4 subjects of Economics.

Honourable Vice Chancellor has emphasized the following points:

- 1. There is a need of change in the focus of teaching. He has suggested that we should not emphasize mathematical and quantitative concepts so much while teaching law students.
- 2. He recommended that the Institutional Economics course be included to the forthcoming semester's curriculum for the B.A.LL.B(Hons.) and B.B.A.LL.B(Hons.). He placed greater emphasis on the syllabus's inclusion of opportunist behavior and asymmetrical information. In addition, he stressed the importance of utilizing the ideas presented in Institutional Economics by Douglass North, Ronald Coase, and Oliver Williamson. Additionally, he recommended including concepts like moral hazard and adverse selection problems in the syllabus.
- 3. He advised the Economics teachers to familiarize themselves with the subjects of Institutional Economics, Law and Economics. He asked all the faculty of Economics to be conversant with the syllabus. Additionally, he recommended making a connection

between the legal profession and the economics concepts to ensure that the students fully grasp the course's importance.

- 4. In order to maximize the effectiveness of the multi-campus meetings, he asked all of the faculties to collaborate well. Before teaching the Institutional Economics and Statistical Foundation with Excel courses, he recommended conducting a faculty development program for those subjects as soon as feasible.
- 5. The newly introduced course, Institutional Economics, was presented by Dr. Vishnu Kedar, and everyone present approved the syllabus.

Dr.Ramesh Bhat, Honourable Vice Chancellor, NMIMS, proposed the following structure for the upcoming batches, which has been unanimously approved by all the faculties and heads of the law school from other campuses.

Introduction of new courses and revision in the Course structure for the B.A.LL.B (Hons.) and B.B.A.LL.B (Hons.) for the batch 2024-2029 and A.Y 2024-25 onwards

- 1. Statistical Foundations with Excel SEM I
- 2. Microeconomics- SEM II

As per BCI Circular dated 20.5.2024 it has been mandated to include the following changes /additions in the existing course structure of B.A., LL.B.(Hons) & B.B.A., LL.B.(Hons). from the academic year 2024-25 onwards.

- a. Incorporate three new enactments i.e. The Bharatiya Nyaya Sanhita, 2023 (IPC), The Bharatiya Sakshya Adhiniyam, 2023 (Law of Evidence), The Bharatiya Nagarik Suraksha Sanhita,2023 (CrPC) into the curriculum of Universities and Centers of Legal Education starting from the academic year 2024-25. Due to these new enactments, there will be corresponding changes in minor criminal Law enactments such as the subjects,
 - i) 1) White Collar Crime & Financial and Systematic Fraud, 2)Penology, Victimology, and Correctional Institutions, and 3)Offences Against Child & Juvenile Offence in **Semester IX**, **credit 3** each of batches 2020-25, 2021-26 & 2022-27
 - ii) 1) White Collar Crime & Financial and Systematic Fraud, 2)Penology, Victimology, and Correctional Institutions, and 3)Offences Against Child & Juvenile Offence in **Semester VII**, **credit 2** each of batches 2023-28 & 2024-29 which will be presented when these batches reach the 4th year of their curriculum
- b. Further, the circular also mentions to include Mediation (with Conciliation) as a specific subject. In this respect, we have restructured the ADR course outline and deleted mediation and conciliation modules, and added in the Mediation subject. Similarly, new modules in ADR subject was added in place of the deleted modules.
- c. It was also instructed to incorporate Computer Education in Law courses.
- **A.** Dr. Anmol Paniya and Ms. Anjali Sharma presented the course outlines for "The Bharatiya Nyaya Sanhita, 2023 (IPC)" in Semester III from batch 2023-28 onwards and "The Bharatiya Sakshya Adhiniyam, 2023 (Law of Evidence)", in Semester V from 2022-27 batch onwards in A.Y 2024-25 which was approved by the Board of Studies.
- **B.** Advocate Shivam Jain Kakadia (VF of ADR) explained the course contents of Alternative Dispute Resolution (Clinical) subject, he added new module Statutory Arbitration (module no. 5) and then explained the Arbitration and Conciliation Act. (Module 7) including the latest case laws.
 - After going through the syllabus Mr. Moin Ladha and Justice B.N. Srikrishna suggested that to include stock exchange arbitration (BSE/NSE) as it is purely Arbitration subject.
 - Advocate Shrikant Aithal mentioned that three important events 1. JSW Steel Case under MSME Act 2. Stamped Arbitration Agreement 3. Group of Companies Doctrine in Cox and king.
 - Advocate Sanjay Notani suggested to include Emergency Arbitration and Amazon-Future Retail Case.
- C. Advocate Shivam Jain Kakadia presented the syllabus for Mediation & Conciliation Law & Practice (Clinical) it is 3 credit course for Semester X, in pursuance of the requirement of BCI.
 - The mediation course outline suggested by BCI in its circular and suggestions of the Hon'ble Members of the BOS are incorporated. The two reference books by Advocate Sriram Panchu on

Mediation were added in the course outline as suggested by Justice Srikrishna and Dr. Nilima Chandiramani.

D. With regard to including Computer Education subject in the course structure in place of Practical Training (Clinical) for the Semester IX, a subject titled as "Meta Skills, ICT and Practical Training (Clinical)" has been incorporated for one credit. The BOS Members approved the course outline. However there was a suggestion from Mr. Harshal Shah that in this subject the emphasis must be more on the technology per se and not the law concerned in that. Use of ICT in legal profession can be taught as a part of example.

"The Bharatiya Nagarik Suraksha Sanhita, 2023 (CrPC)" is subject to be taught in Term II which will be placed before the BOS in the month of August/ September 2024 and in the following Academic council meeting.

- i) To comply with the guidelines of BCI regarding the integration of Computer Education into Legal Education, the nomenclature of Practical Training (Clinical) course (credits 4) is changed to "Meta Skills, ICT & Practical Training (Clinical) (credit 1) in Semester IX in AY. 2024-25 batches 2020-25 onwards.
- ii) A new course is introduced titled "Mediation & Conciliation Law & Practice (Clinical), (credits 3) in Semester X for the batches 2020-25, 2021-26, 2022-27 in A.Y 2024-25 onwards and in Semester VIII of batch 2023-28 onwards.

The Board of Studies recommended that after due incorporations of the changes suggested by the learned Members, all syllabi and the other decisions approved during the 27th BoS Meeting Part III (Online mode) may be submitted to the Academic Council meeting for the University's approval.

Accordingly, all the observations and suggestions made by the respective members are duly incorporated in the relevant places of the course outline.
