Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

| Sr. No. | Percentage of Refund of Fees* | Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI) |
|---------|-------------------------------|--|
| (1) | 100% | 15 days or more before the formally-notified last date of admission (on or before 22nd September 2021) |
| (2) | 90% | Less than 15 days before the formally-notified last date of admission (from 23rd September 2021 to 8th October 2021) |
| (3) | 80% | 15 days or less after the formally-notified last date of admission (from 9th October 2021 to 23rd October 2021) |
| (4) | 50% | 30 days or less, but more than 15 days, after formally-notified last date of admission (from 24th October 2021 to 7th November 2021) |
| (5) | 00% | More than 30 days after formally-notified last date of admission (from 8th November 2021 onwards) |

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount subject to maximum of Rs.5000/-

Note :

1. The above refund rules are as per University Grant Commission (UGC) notification on Refund of fees and Non – Retention of Original Certificate.
