**Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees\* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission ( <b>on or before 2<sup>nd</sup> August 2021</b> )
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission ( <b>3<sup>rd</sup> August 2021 to 18<sup>th</sup> August 2021</b> )
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission ( <b>19<sup>th</sup> August 2021 to 2<sup>nd</sup> September 2021</b> )
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission ( <b>3<sup>rd</sup> September 2021 to 17<sup>th</sup> September 2021</b> )
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission ( <b>18<sup>th</sup> September 2021 onwards</b> )

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount subject to maximum of Rs.5000/-

Note :

1. The above refund rules are as per University Grant Commission (UGC) notification on Refund of fees and Non – Retention of Original Certificate.
