1. Introduction:

This booklet gives information about the Admission Procedure for **Master of Law (LL.M.) 2 years full time program**.

2. Specialization & Intake: Total 50 Seats. Mumbai Campus.

Following specialization will be offered: **Master of Law Program 2 years full time program.**

3. Duration:

Master of Law (LL.M.) 2 years full time program

4. Eligibility criteria: (Fulfillment of all / applicable conditions mandatory)

- 4.1 The candidate should have passed in the examination conducted by a recognized University leading to award of LL.B. degree (**minimum 50% aggregate marks**).
- 4.2 The candidate will have to appear for Entrance test conducted by NMIMS (Deemed to-be-University) or the candidate shall have passed the Common Law Admission Test for LL.M. (**CLAT PG**) for 2022 with valid score **or** Post Graduate Common Entrance Test in Law (**PGCETL**) conducted by (Bar Council of India) BCI/BCIT (The Bar Council of India Trust) with a valid score.
- 4.3 Candidates appearing for the final year examinations are eligible to apply. If selected, provisional admission will be given subject to clearing the final examination. Fees will be accepted from such candidates but their admission will be confirmed on the submission of final mark sheet within given due date.
- 4.4 At the time of admission, candidate has to produce semester-wise/ trimester-wise/ consolidated (only if individual mark sheets are not issued by University/Institute) mark sheet of all years of the college from which he/she is graduated. In case of internet copy of mark sheets, attestation by Principal with official seal is mandatory.
- 4.5 In case the mark sheets issued by applicable board / University is in percentile/s or grade point the actual aggregate percentage of all subjects appeared by the candidate will be taken into consideration.
- 4.6 The candidates, who have passed or, have appeared for graduation examination from a University where grade point average is given, must produce the equivalent percentage for the GPA/CGPA obtained in writing from the University concerned.

- 4.7 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their graduation / post-graduation from Overseas University.
- 4.8 Candidates who have cleared their graduation by doing part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.
- 4.9 It is the sole responsibility of the candidate to ascertain whether they possess the necessary and requisite qualification for the admission at NMIMS, as verification of the document is done at the time of final admission.

5. Admission Process:

5.1 Online Registration & Payment of Registration:

- Visit www.nmims.edu for online registration
- Before filling the online form, please read all the instructions carefully mentioned in the instruction sheet, important dates and also Terms & Condition given in the online application form.
- Online Registration Fee of Rs.2500/- (Please refer online registration for payment details.)
- Registration Fee is non-refundable.

5.2 Call Letter:

Candidates registered successfully as per eligibility criteria will be called for Online Entrance test & Personal Interview. On the basis of information indicated in the Registration Form, call letter for Online Entrance Test & Personal Interview will be communicated to the candidate as per important dates through NMIMS website.

Submission of Documents: Candidate have to upload below mentioned list of document given **in call letter for NMIMS Online Entrance Test and Personal Interview**. It is important and primary requirement to upload the mandatory documents to execute the

List of Documents: Online Entrance Test and Personal Interview process.

1. Copy of duly filled Online Application Form (mandatory)
2. 10th & 12th Mark sheet & certificate copy (mandatory)
3. Valid score card for Common Law Admission Test for **LL.M (CLAT PG) for 2022** or Valid score card of Post Graduate Common Entrance Test in Law (**PGCETL**) conducted by (Bar Council of India) BCI/BCIT (The Bar Council of India Trust) whichever is applicable. Candidates applying on basis of NMIMS Entrance Test may ignore this point.
4. Degree mark sheet all years – 5 years / 3 years & Degree Certificate (Convocation Certificate) (Mandatory)
5. Work Experience Certificate (if applicable)
6. Statement of Purpose (SOP) (mandatory) - Format given below.
7. Any Research/ Academic contribution by you in the form of Publication
8. Credentials for participation in co-curricular activities and competitions like Moot Court
9. Short term certificate course or participation in workshops/ seminars

Candidate will not be permitted to attend **NMIMS Online Entrance Test/ Personal Interview** or to join the program unless he/she has uploaded list of Documents (as mentioned above) on time AND complete the selection process successfully.

A set of photocopy of the above mentioned documents have to be kept handy by candidate when they appear for NMIMS Online Entrance Test & personnel interview.

- Candidate's application form will not be considered if they fail to upload the above mentioned documents **on or before Monday, 1st August 2022 by 12.00 noon**
- No candidate without call letter will be permitted to appear for the Online Entrance Test & personal interview.
- Candidate must carry any one requisite original ID proof for appearing for the Online Entrance Test & personal interview.

1. Voters ID
2. Passport
3. School/College ID
4. Aadhar Card
5. Driving License (Learner license will not be accepted)
6. PAN Card

6. Selection Procedure:

NMIMS Entrance Test / Common Law Admission Test for LL.M – 2022 (CLAT PG) / or **Post Graduate Common Entrance Test in Law (PGCETL) conducted by (Bar Council of India) BCI/BCIT (The Bar Council of India Trust)** and Personal Interview

Note : Those candidates who have valid scores in Common Law Admission Test (CLAT PG) / or **Post Graduate Common Entrance Test in Law (PGCETL)** are exempted from NMIMS online entrance test. **However, Personal Interview will be conducted for all candidates.**

NMIMS Online Entrance test : Maximum Marks 150. Time : 150 minutes.

Personal Interview : Maximum Marks: 30

- Final merit list will be prepared on the basis of the marks obtained in the Online Entrance Test/ CLAT PG /or **Post Graduate Common Entrance Test in Law (PGCETL)** & Personal Interview.
- Admission offer is given as per merit and vacancy. WAITLISTED candidates have to check their merit list status as per date given on the website.
- Once the merit list is declared, candidate has to login to check result on NMIMS portal using his / her credentials. If selected, candidate has to **accept or reject** the offer. If, offer is

accepted, SELECTED candidate should upload necessary required document and after verification of the uploaded documents by admission department; the candidate will get the fee payment notice e-mail (RTGS / NEFT details) for the payment of course fees within the stipulated time frame.

- Changing of preference will be considered, only if you are selected & offer given for higher preference in the subsequent merit list as per preference, merit rank and availability of seat.
- The selection will be solely based on merit.
- The cut-off for deciding the merit shall lie solely with NMIMS.

7. Program Fees:

- The Fees for Master of Law (LL.M.) Program for the year 2021-22 was Rs.1,50,000/-p.a.
- The fees for the year 2022- 23 will be declared at the time of admission.

8. Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more before the formally-notified last date of admission
(2)	90%	Less than 15 days before the formally-notified last date of admission
(3)	80%	15 days or less after the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

Note: 1) Candidates to refer Important Dates of the respective programme.

9. Important instructions:

- **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Please use the below link for admission cancellation form.

Candidate has to upload cancellation form duly filled and signed along with fees paid receipt copy & cancelled cheque (personal account).

- Please note that it is responsibility of the candidate to check whether he/she is eligible to apply for the Program as per the eligibility criteria declared on the website. NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. In such case, the admission of the candidate even if selected and fees paid stands cancelled and the fees paid will be forfeited.
- Please see the important dates and preserve it as a guide. All announcements from the University will be through its web site www.nmims.edu. No separate call letter / admission offer letter (if selected) will be sent by email / courier / post.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her application for admission to the program, even if selected, will stand cancelled and fees will be forfeited.
- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible, admission will be cancelled and fees will refunded as per prescribed refund rule.
- Canvassing in any form will disqualify the candidate.
- All matters of disputes will be subject to the legal jurisdiction of Mumbai only.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given.
