The Candidates must check his/her eligibility before applying for the course.

### **Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees\* remitted by the student.

<b>Sr. No.</b>	<b>Percentage of Refund of Fees*</b>	<b>Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)</b>
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission <b>(on or before 17<sup>th</sup> August 2021)</b>
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission <b>(from 18<sup>th</sup> August 2021 to 2<sup>nd</sup> September 2021)</b>
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission <b>(from 3<sup>rd</sup> September 2021 to 17<sup>th</sup> September 2021)</b>
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission <b>(from 18<sup>th</sup> September 2021 to 2<sup>nd</sup> Oct 2021)</b>
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission <b>(from 3<sup>rd</sup> October 2021 onwards)</b>

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.

**Note:** Candidates to refer Important Dates of the respective programme.

The above refund rules are as per University Grants Commission (UGC) notification on Refund of Fees and Non-Retention of Original Certificates of October, 2018 and are subject to revision as per UGC notification (as applicable). Please note the closure of admission/last date of admission as mentioned in the refund is **Thursday, 2<sup>nd</sup> September 2021.**
