Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

(4)		30 days or less, but more than 15 days, after formally-notified last date of admission (14th August 2020 to 28th August 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (29th August 2020 onwards)

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
