NMIMS Entrance Test for UG Admissions For Academic year 2025-26

SVKM's NMIMS conducts the UG Entrance examination every year for class XII passed out / appearing candidates to be eligible to their UG Programs across campuses.

The Entrance Examination is a computer based online examination to be held at the **test centers**. It is categorized into four different categories namely:

- NMIMS-NPAT
- NMIMS-CET
- NMIMS-MST
- NMIMS-LAT

The candidate has to ensure that they read all the instructions carefully before registering.

- <u>RETAKE/S:</u> Candidate can attempt maximum 2 RETAKES in any selected category i.e. (1st main test plus 2 retakes). The highest marks among the total attempts will be considered for respective school merit process.
- Once the main exam delivery is done, candidate cannot add new school in the same category for retake, but he / she can add new category of test.
- Candidate is recommended to schedule exam/s slot at the earliest to avoid last minute disappointment to
 get a convenient / date preferred optimal slot. There will be a chance, not to get the preferred / optimal slot.
 NMIMS Management will not be responsible for such arrangements.
- Strictly NO Rescheduling or cancellation is allowed

Important Instruction for candidates registered for NMIMS-CET (Engineering + Pharma) & NMIMS - MST (Mathematics, Statistics & Data Science) & NMIMS-LAT (Law)"

Admission process for NMIMS-CET (Engineering + Pharma), MST (Mathematics, Statistics & Data Science) and NLAT (Law) for Batch-2025 will be held in **two phases** as per the above schedule mentioned. Candidates are requested to check the respective school's website for further information.

- Candidates registered for Phase-1 NMIMS-CET (Engineering + Pharma), NMIMS-MST (Mathematics, Statistics & Data Science) and NMIMS-LAT (Law) should give minimum 1 attempt in Phase-1, maximum two attempt (that means main + retake-1) in Phase-1. He / She can attempt Retake/s (Retake-1/ Retake-2) in Phase-2.
- Candidates can register for Phase-2 NMIMS-CET (Engineering + Pharma), NMIMS-MST (Mathematics, Statistics
 Data Science) and NMIMS-LAT (Law) and can give main + retake/s (Retake-1 and Retake-2) in Phase-2.
- Separate Merit list will be declared for Phase-1 candidates based on best score available & admission / counseling for Engineering, Pharma, MST and Law accordingly.

- Phase-2 Separate merit list will be prepared which includes Phase-1 candidates also, along with their updated best scores amongst all attempts. Admission / counseling for Phase-2 will be given on updated merit number based only.
- Phase-1 / Phase-2 seats will be allotted distinctly and sanctioned by NMIMS Management. It will be entirely
 discretion of NMIMS Management.
- Further details will be available in admission / counseling offer letter.

E-mail confirmation:

Post scheduling of the examination, the confirmation mail from (<u>pearsonvueconfirmations@pearson.com)</u> will
be sent to candidate's registered email ID. The same email / admit card needs to be presented at the test center
at the time of test. Candidate will receive separate email for each exam scheduled.

Admit Card:

- Post scheduling of the examination the admit card is generated. The admit card shows the chosen date of examination, City and Test center.
- This is available on the dashboard of the Candidate. Kindly download the admit card by logging to your dashboard.

Test Center:

- Candidate needs to show the Admit card (hard copy) as a primary ID proof and any document from listed below as a secondary id proof (hard Copy) to the Test center staff.
- The verification staff at the test center will compare the photograph on the admit card with the person appearing for the examination. Therefore, candidate is requested to upload their recent photograph to avoid any confusion at the test center.

<u>List of ID proof that candidate can carry to the test center</u> are as below:

- Voters ID / Passport / Aadhaar Card / Driving License (Learner license will not be accepted) / 12th Board Admit Card with photo / PAN Card.
- The name on the original Government ID must exactly match with the name mentioned on the appointment confirmation email.
- Candidate will be allowed to attend computer-based test only on the scheduled date/time.
- Candidates should reach the test center at least 30 minutes before the time of exam.

Provision for Physically Challenged Candidates:

The candidate must upload their Disability Certificate at the time of online registration.

- This will be reviewed and approved by the NMIMS authority.
- Post the approval, the candidate will get email on their registered email ID. Further he / she can make the payment and schedule the examination.
- Appropriate assistance will be made available at the test center.

Important Instructions with regards to Application and scheduling examination: -

- Candidate can register only once for each category. Duplicate registration from same candidate will be rejected, even if exam is taken. Both registrations will be annulled and fully discretion by NMIMS, at any stage of admission process.
- Test center and date has to be chosen by the candidate only. Once chosen it cannot be changed at any reason.
- Candidate will have to report for exam on the scheduled date and time only. Rescheduling or cancellation of exam / registration is not allowed.

• **Diploma awarded** candidates from International Baccalaureate (IB) Board are considered to 10+2 or equivalence examination with 24 grades/credits compulsory and has passed 3 subjects at Higher Level (HL) and 3 subjects at Standard Level (SL) plus extended essay and TOK

- **DP course** candidates from International Baccalaureate (IB) Board are considered to 10 +2 or equivalence examination with 2 subjects at Higher Level (HL) and 2 subjects at Standard Level (SL) OR 3 subjects at Standard Level (SL) and 1 subject at Higher Level (HL)
- a. IBCP equivalence for General Strand (Arts, Commerce, Science, Law): CP course candidates from International Baccalaureate (IB) Board are considered 2 DP subjects with at least 1 subjects at Higher Level (HL) and minimum 3 points in each DP subject along with Career related studies with at least 03 subjects offered by IB.
- **b.** IBCP equivalence for Engineering or Medicine Strand: CP course candidates from International Baccalaureate (IB) Board are considered 3 DP subjects (Maths, Physics, Chemistry, Biology or other similar subjects) with at least 1 subjects at Higher Level (HL) and minimum 03 points in each DP subject along with Career related studies with at least 03 subjects offered by IB. Further eligibility criteria as stipulated by statuary bodies like AICTE
- Candidates of CBSE / ICSE, should mention in the online registration / e-admission form (if selected) for 10+2 or equivalent examination, the aggregate marks of all the subjects the candidate has taken / opted and appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects he / she has taken / opted and appeared in the applicable examination/s in a single attempt. The aggregate percentage of all subjects the candidate has taken / opted and appeared will be taken into consideration for confirming eligibility of the candidate for the program at the time of admission.
- In case the mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.
- Candidates above 25 years of age can apply for B.A LLB and BBALLB programs only under NLAT Exam category. For all other programs the age criteria is Maximum 25 years of age.
- Those candidates who have passed or are appearing (all subject/s taken / opted) for 10+2 examination from a Board / University where Grade Point Average is given, such candidates must produce in writing from the Board / University concerned, the equivalent percentage for the GPA / CGPA obtained.
- IB & Cambridge Candidate: Candidates who do not have final mark sheet will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed on submission of final mark sheet before the commencement of the program, if found eligible. The candidate shall have to submit copy of AIU notification to confirm their eligibility for the program as equivalent to (10+2) examination/s. The mark sheet/s/transcript/s issued by Board / University shall only be considered.
- International School/s candidates and those candidates who have completed their (10+2) or equivalent examination/s from overseas school/s / Institute/s / University will have to submit AIU certificate of equivalence

(mandatory) to confirm their eligibility for the program as equivalent to (10+2) examination/s. Applicable to candidates of distance learning/ correspondence course/ open school too.

- Only single mark sheet with all compulsory subjects passed is mandatory, no compartmentalized mark sheet will be considered.
- Candidate whose final mark sheet is not available at the time of admission is required to upload internet copy /
 DG Locker of result duly attested by Principal of the school / college, failing which candidate will not be admitted
 for the program.
- Candidate will not be eligible if any subject is marked as ungraded / fail in the mark sheet / grade sheet. For absent / ungraded in any of the additional / non mandatory subject will be consider as eligible provided such candidate is declared as passed by respective board.
- Candidates appearing for their final 10+2 or equivalent examination can also apply provided they must obtain the required minimum eligibility criteria of the respective program and produce the entire necessary documents, in original, within the given stipulated time.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected/ admitted, will stand cancelled and fees will be refunded as per refund rule clause.
- Candidates who have cleared their 10 + 2 (12th Standard) by doing a part time course or through distance learning, correspondence course externally, open school from a recognized University are eligible to apply & register as per UGC guidelines
- As per program eligibility the mandatory subject should be appeared and passed.

Selection Process:

- Merit list will be prepared based on the performance of the candidate in NMIMS-NPAT / NMIMS-CET / NMIMS-MST / NMIMS – LAT exam.
- The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained

Note:

- Candidates are required to update 12th or equivalent exam or predicted marks after the admission process.
- Candidate will not be considered for merit list if they fail to update the correct information in the online registration form.

- It is the sole responsibility of the candidate to ensure that correct marks are entered.
- At any given point of time, if it is found that the information given by candidate i.e 12th or equivalent exam is incorrect, the candidate admission will be cancelled and fees will be refunded as per prescribed refund rules.
- For Engineering: Candidates will be called for Counselling as per their merit. In the counseling session, candidates
 will be given admission to various specialization as per their merit, choice and availability of specialization as per
 eliqibility criteria.

Refund Rules for all programs / Schools

Refund Rules: As per the notification of UGC. Details will be shared at the time of admission.

Important Instructions after merit list:

- For cancellation / withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate should visit https://upload.nmims.edu/admission/cancellation/
- Canvassing in any form for admission will disqualify the candidature.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected, will stand cancelled and fees will be refunded as per refund rule clauses.
- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.
- We need minimum 10 candidates to start a program.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- Admission to program is considered as "Provisional Admission" till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/admitted to the program.
