The event brought together scholarly legal minds from various institutions across the nation as well as several working professionals who contributed through their experience and expertise.

Dr. Alok Misra, Dean - KPMSoL, Director of National Seminar, had declared academic year for 2021-22 as year of awareness of Cyber Laws for all the law schools. Accordingly this National Seminar was planned to be organised on Cyber Laws.

The Inaugural ceremony began with a brief introduction about the Associate Dean, Prof. Sohini Shrivastav, who is also Co-Convenor of the National Seminar, by Viloni Dedhia. The respected Associate Dean then addressed the gathering. Following this welcome address, she declared the seminar open. The Vote of Thanks for the Inaugural Ceremony was delivered by Asst. Prof. Anu Mishra, Co-Convenor, National Seminar.

The welcome address for the valedictory ceremony of the Seminar on Cyber Law was delivered by Viloni Dedhia. Dr Yashomati Ghosh, Professor at NLSIU, was the Chief Guest for the event. She elucidated upon several pertinent issues pertaining to cyber law and briefly summarised the issues as well as potential of cyber law as an area of practice and research. Post the address, Dr Yashomati Ghosh was requested to announce the awardees of the conference.



Pehchaan, Zoom, Jan. 29th-30th — Pehchaan hosted its first National Level inter-college festival, "Jashn-e-Pehchaan," to celebrate the diverse cultural identities prevalent in India. "Atrangi," a performing arts event, kicked off the festival on the first day. Atrangi invited participants to showcase their identity through dance, poetry, and music. A myriad of performers took the virtual stage to embrace their identity through enthusiastic performances. This was followed by "Alag Nazariya," a mono-act event. "Kahani Unsuni" was a platform for participants to get candid and recite their stories. The first day of Pehchaan concluded with "L'artiste," which highlighted social issues through paintings and art.

The second day began with "Kitne Offensive The," which allowed participants to discuss offensive depictions in the media. Novice Moot Court Competition 2022

IMCC, Mumbai, Jan. 21 - The Moot Court Committee of NMIMS School Of Law, Mumbai, organized the Novice Moot Competition. The theme for the event was Law of Torts, which was fortunate, considering that it was one of the subjects being studied by the First Year Students!

Before the event itself. multiple seminars were held by distinguished and experienced guests to highlight the importance of mooting and give the students some tips and tricks for the same. Each team consisted of Three Participants - two speakers and one researcher. who were all individually.

Each team had to submit two memorials, both for and against the fictitious case at hand, which was a useful exercise in understanding both sides of any case as well as the likely arguments of the opposition. The Committee invited 14 judges for the competition, each "courtroom" had 2 Judges, 4 Speakers, 2 Researchers, and a Timekeeper.

What made the event so valuable and enriching was the personal feedback that the judges gave to each and every member.

They suggested to the young students aspects they could cultivate, improve upon, or inculcate and which they had

to set aside for future Moot Competitions, making it a very rewarding first moot experience for such novice mooters and aspirants of Law.

"Learning The Know How's of Mooting" Workshop

The discussion covered the fundamentals of moot such as defining a moot problem, the components of a memorial presented. and the oral rounds procedure. There was also a query round where the students raised while queries and doubts the of committee representatives the attempted to solve them. The Session was successful in making the students feel at ease with the concept of mooting.

Podcast Launch-Contemporanea Lege By Centre Of Excellence-

Centre of Excellence, Spotify, Sep. 10 - The Centre for Excellence of NMIMS Kirit P Mehta School of Law, Mumbai, debuted its podcast, Contemporanea lege, on the platform Spotify. On September 12th, 2021, the first episode of the podcast was released in audio format.

National Webinar On 'Safeguards Against Private Actors And Intermediaries: Discussing The Evolution Of The Data Protection Bill'

CyberCell, MS Teams, Dec. 10 - The CyberCell at NMIMS Kirit P. Mehta School of Law hosted a National Webinar with the purpose of spreading awareness about personal data protection. The webinar consisted of a dialogue with Dr. Swapnil Bangali and Dr. Alok Mishra, Dean, Kirit P. Mehta School of Law.

Dr. Swapnil Bangali is an honorary Director of the Center for Information Communication Technology and Law at Maharashtra National University. Holding 15 years plus worth of teaching experience, he's well versed in Cyber Law and various other subjects. He has authored a book on "Law relating to Contraventions under the Information Technology Act, 2000" and presented a plethora of papers on issues in the field of IP and IT Laws at various national and international conferences.

The session was highly informative and educational, each participant was enlightened about the nuances of personal data protection and the law thereon.

The first half of the webinar was dedicated to privacy - how it is perceived by the society v law and the scope of improvement under the Indian law. Dr Swapnil discussed the concept of data in great detail and distinguished between personal v. nonpersonal data. Quoting the Justice K.S. Puttaswamy vs Union and its judgment, he debated whether privacy was real and up to what extent should the government go to protect it. He also discussed if the right to privacy should be deemed as an absolute right

The second half of the webinar primarily focused on data protection in various environments and a comparison of data protection laws in various countries primarily - the UK, Europe, and India. Dr. Swapnil praised the way India was handling data protection laws and the progress in the cyber sector in general. He

mentioned how prompt India was to come up with regulations to protect the data and the efficiency of the Indian government in this area.


Awareness Session Basics of Social Entrepreneurship

Innovation, StartUp and Entrepreneurship Committee, Zoom, Dec. 15 – On 15th December 2021, an awareness session was hosted by the Innovation, StartUp and Entrepreneurship Committee of NMIMS Kirit P. Mehta School of Law, on the Basics of Social Entrepreneurship. The guest speaker for this session was CA Parshuram Khawle, the Co-Founder of Bookshare India and a Padma Shri Nominee for 2022.

The session started with a few words by the Dean, Dr Alok Mishra. The guest speaker was then introduced by Prof. Deepika Chhangani. Mr Khawle then took over and described how his journey of social entrepreneurship started in the year 2016. He talked about Book-Share India's three modules, namely, Book Donation, under which donation points are established across India and an app that guides you to the nearest book spot; Book Sharing, in which you list down the books you own, and using Jio locations the reader contacts you; and other activities such as setting up of libraries, going to municipal schools in villages, and highlighting the importance of reading.

He explained the process of becoming a social entrepreneur. It is imperative to find co-founders who are passionate about the problem, towards their work, and possess the necessary soft skills. He spoke about the importance of team building and how HR is the pillar of an organization. An entrepreneur who has a social goal and provides selfless service is a social entrepreneur. Various examples were given for a detailed understanding. Mr Khawle then highlighted the challenges faced by his startup and ways to overcome them.

Questions were asked at the end, which were answered by Mr Parshuram Khawle. A vote of thanks was given by Ojaswi Bhagat, who thanked the guest speaker for sharing his thoughts and being a part of the insightful session.





The Centre for Excellence organised "Faux Pas: Alternative Judgement Writing Competition", as a part of the UGC's celebration of 75 years of Indian Independence, Azadi Ka Amrut Mahotsav: under the astucious guidance interminable encouragement of Dean, Dr Alok Misra, and Prof. Anu Mishra. Commemorating this propitious day, the Centre for Excellence conducted the alternative judgement writing competition, holding in question the judgement of "Union of India v. Naveen Jindal & Anr." in the Supreme Court, wherein the right to hoist the national flag was the main contention.

The competition was open to teams of up to two members, and submissions were invited from students pursuing a 3-year LLB or 5year integrated LLB programme from any college within India. This competition aspired to promote the creative and critical thinking of students. encourage augment the research and writing skills of participants, and assist students in honing their creative skills of interpretation and clarity of thought, analysis and application of various legal provisions in the drafting of a judgement. The competition introduced the participants to the mechanism of eloquent and clear judicial drafting, application of law to a factual matrix, and had the effect of instilling in the minds of the budding legal professionals the spirit of the rule of law, the principles of justice, equity and good conscience.


The release of judgement was done on the 9th of August, 2021, and the deadline for registration and submission the of judgement was extended to the 31st of August. 2021. The judgements were evaluated and marked based on several criteria, including adherence to formatting guidelines, clarity of thought and coherence language, interpretation of facts. identification of issues, application of legal provisions and the adequacy of the justification provided for the ratio decidendi. The inclusion of suggestive improvements in the Indian legal perspective, was also considered.

Pehchaan Panel Discussion on Male Domestic Violence

Pehchaan, Zoom, Oct. 26- The Panel discussion was organised by Pehchaan on the topic "Male Domestic Violence and its Effect on Men."

The Panellists were accomplished faculties of Kirit P. Mehta School of law, Prof. Karishma Desai and Prof. Afrin Khan along with the students.

The hosts for the evening were Rohan and Rushank. The discussion started by tracing the assumptions that ultimately lead to male domestic violence. There was a discussion on various factors that lead to male domestic violence, various loopholes in the Indian Legal system, and the necessity to recognise this offence. After the faculties, students raised their opinions and led the discussion forward.



The abuse need not necessarily be physical, there can be other forms of abuse as well, which can affect any family member. The discussion elucidated on the scope of the topic and based on the factors that contribute to male domestic violence, the assumptions in the social fabric behind male domestic violence which are making it a taboo, the legal remedies to reduce such instances, and spreading awareness so that it is recognised. Followed by the discussion, Fatima Ali Khan, Chairperson of Pehchaan, gave a vote of thanks and expressed her gratitude to the faculties for their constant support, the whole team behind the discussion, and the other participants in the meeting for their opinions and efforts.

Suggestions for the Draft Drone Rules

Centre of Excellence, Cross-Platform, Aug. 5

The Centre for Excellence submitted Suggestions for the Draft Drone Rules, 2021, by the Ministry of Civil Aviation. Drones are extremely useful tools that have, as a product of technological innovation, revolutionized several aspects of life. The Centre for Excellence thus undertook to provide suggestions to the lawmakers in the drafting of the Draft Drone Rules 2021, some of which were incorporated in the final draft of the document as well. The committee conducted an inter-country comparative analysis, by examining the Civil Aviation Act of the United Kingdom; considering the requirement for registration, declaration of weight, the height of the flight, and other details, as is made in many countries like the US, Israel, Japan, China, and Austria; the need for a declaration of the purpose of use of a drone as commercial or recreational, as is mandated in Austria and Israel; in order to assess the workings of the legislative mechanism in other countries in this regard, and analyze the potential for incorporation of those measures in Indian domestic legislative framework. Following the elaborate process and procedure of suggestion the document containing the same was sent across on the 5th of August 2021.

Quizzical 2.0

Quizrit committee of NMIMS Kirit P. Mehta School of Law conducted Quizzical 2.0- a competition that attracted many participants from

Alternate Dispute Resolution Committee, Zoom, Feb. 3-4

The 2nd National Virtual Mediation Tournament was hosted by the Alternate Dispute Resolution Committee of NMIMS Kirit P. Mehta School of Law, Mumbai. Several notable individuals from mediation and arbitration fields graced the occasion. The panel of judges included, Adv. Kavitha Balakrishnan who is one of the founding ambassadors of Mediation Networking of Mediators and Adv. Renu Parekh, the Director of the Indian Arbitration Forum.

The intent of the Tournament was to develop the collaboration, communication and negotiation skills of participants. 24 colleges across India participated in this tournament with a total of 72 participants. Comprising of 4 rounds in total, the participants were given a prior briefing of the rules and scoring.

The Finals' Round involved a dispute between the Government of the Country of Bogwarts and a well-known Car Manufacturing Company over various transactions. Students from Hyderabad's NALSAR University of Law and Bhopal's National Law University were the teams that reached the Finals.


PARAKRAM 2022
