

STUDENTS WRITE ABOUT THEIR VIEWS ON ABROGATION OF ARTICLE 370 IN KASHMIR

Article 370 was a temporary provision. The rising tension in Kashmir has been a headache for India. The maintenance of the armed forces in the area has had a huge cost. Hence, the area should be opened to economic activities because firstly, it would provide employment to the people there. Secondly, the government can earn some revenue from the increase in tourism which could satisfy the cost of maintaining an army. Thirdly, this will reduce terrorism as making it a UT brings it under the President- the commander in chief of the armed forces.

On Article 370



Article 370 (3) gives the President the power to scrap the special status of J&K and thus the process was far from unconstitutional. Article 370 allowed Indian Government to interfere with the defence, communications and foreign affairs of J&K. Statistics say that Government spends 6 Crores a day on Kashmir's security, that's 2190 crores a year! That's the same amount allotted to the Srinagar Metro, which, is more peaceful and productive than military intervention.

The provision allowing only Kashmiris to own land and hold administrative posts was a hindrance for the development of J&K. The administration is another important spectrum through which the issue at hand can be analysed. J&K as a state almost functioned like its own country where many of the regulations of Indian Law didn't apply.

For instance, J&K bank presumed the role of the RBI in terms of policymaking, however, mismanagement led the Kashmiri economy to ruins. To add to this, the administrative officers looking after the day to day activities of the state were restricted to only State Citizens who considered a post in places like Drass and Leh to be a curse, hiding the district in a cloud of neglect. Moreover, the district of Ladakh has a distinct cultural identity of being a Buddhist majority region thus it was essential that these people receive the due attention that was required for development and national integration through proper and effective administration. It is also important to understand that love for a nation can't be forced and peace cannot be enforced through a curfew, it is solely through economic progress and an increase in positive opportunities.

The book, "The Spy" by Paulo Coelho, is about a woman who was celebrated by some and condemned by others, but remembered - Mata Hari. This book revolves around the life of Mata Hari and how she paid the price of being an independent woman who challenged the beliefs of the society with every movement of her body.

Mata Hari has always wanted to be significant to the world and to go places, and to places she went. This book talks about how men in those times and since, would rather end the life and reputation of an innocent women than satisfying the aspirations of her soul and acknowledging herr shortcomings. It portrays love as something which cannot be dominated and shall remain a mystery, only to be felt; if its mystery is disturbed, love can destroy and disappear.

The first lesson that the life of Mata Hari taught me was not to fear freedom. As astonishing as that sounds, most of us, if not all, desire freedom but we also fear it. This is because absolute freedom of mind and soul is unknown to us and; since times immemorial, men and women have always feared the unknown. Mata Hari was born at a time where women didn't know what freedom and independence meant, they only knew of a life where women are to be oppressed by men. Mata Hari knew that too, but what made her different and remembered is that she did not accept her fate, she made it.

The book also makes one realise that disguising one's past never relieves one from the woes of their past, it only prolongs it.

When charged with espionage, her lawyer said, "You thought innocence was enough to extract you from the web of legal system on which we have always prided ourselves, but that in these times of war has become an aberration of justice". Through this, he explains that justice is different during war times than in peace. This book also helps one to understand how sufferings makes one not believe in the aspect of love and makes one want to dominate it, which cannot be done. It also talks about how important it is to accept that one has been a victim of circumstances than to continue not acknowledging the same.

'Son, it is enough for me to be sure that you and I exist at this moment.'

Written by Colombian novelist and journalist Gabriel Garcia Marquez and translated from Spanish by Gregory Rabassa, One Hundred Years of Solitude chronicles the life of the Buendia family from the fictional town of Macondo over seven generations. Each member of the family faces their own struggles coming to terms with solitude and finding the true purpose of their lives, but these struggles resonate so closely with those of their ancestors that the book has a cyclical effect in the mind of the readers. Written with the backdrop of the Colombian Civil War between the Liberals and the Conservatives, as well as the advent of Industrialisation and the struggle for Labour Rights, parts of the book appear to be a historic understanding of what Colombia was between the 1910s to the 1960s. Employing such a backdrop, Garcia Marquez has also infused mystical aspects within the book, like 'insomnia' being a communicable epidemic, a romantic mechanic who has yellow butterflies following him wherever he goes, a whimsical and exceptionally beautiful girl who is so angelic that she ascends to heaven and many more such incidents. The conflict of these realities existing within the same book makes it a classical example of the literary genre of magic realism where supernatural incidents appear to be close to reality and real life experiences seem absurd. One such inevitability; Death appears absurd to the reader as the characters seem to have immense control over their own deaths, A person doesn't die when he should but when he can. In such circumstances the protagonists of the story, a wide array of Aurelianos, Jose Acardios and Remedios', go on to fulfil their destinies because races condemned to one hundred years of solitude did not have a second opportunity on earth.

Guest Lecture on the 2019 Arbitration Amendment Act

Teacher's Day Celebrations at KPMSoL

Teacher's day has always been a very cheerful and content celebration for the School of Law. Hustling between the 8 am lectures to the never-ending submissions, S tudents of KPMSOL put their best foot forward on the big day. This year, due to heavy spell of rains the event had to be postponed from the 4th of September to the 9th of September. But rains did not hamper the spirits of KPMSOL. The Juhu Jagarati Hall was packed with students from each year gushing with energy to sing, dance and gather every possible chance to hoot.

It was impossible to hold the audience after the program started. The first years, as usual had the most enthusiasm which was clearly seen throught theirperformances. The performances ranged from the power packed dances to soulful singing performances to the shayaris and the drama, each of which was hugely applauded. The stars of the show however, were the professors as they danced to the tunes of various.

The celebration ended with the Student Council giving a vote of thanks.

The guest lecture started with Mr. Alok Jain giving a brief introduction and his work profile in the Economic Laws Practice. He came to discuss the amendments in the Arbitration and Conciliation Act, 2019. He said that the amendments were not really expeditious and the reason for the same were the amendments. The base for the 2019 amendments were the 2015 amendments.

The need for amendments was primarily due to delay and cost. Money is charged on per hearing basis which is mainly the reason why the arbitrators drag matters. The need for Section 11 of the amending act was discussed and how the 2015 amendment limited its scope of court intervention. According to him, the 2015 amendment was a better amendment than the 2019 amendment.

The pros of the 2015 amendment was that timelines were introduced which was very important because adjournments were taken and granted very frequently and easily. The cons were that the amendment was not able to check the section 11 and court intervention. Also, patent illegality was only for domestic and not foreign jurisdictions.

The Shrikrishna Committee report, its bench and the decision was also discussed. The notified provisions, i.e. Section 19, section 17, section 23, section 29A, section 34, section 42A, section 42B, section 45, section 37, section 50 were discussed in length. The non-notified provisions discussed were section 11, section 2(ca), and section 43, among others. At last, the prospective application of 2015 amendment was discussed.

The session ended with the students getting cursory insight into the provisions of the Arbitration Act 2019.

Guest Lecture - Mr. Shailesh Gandhi

NMIMS Kirit. P Mehta School of Law had the privilege to host Mr. Shailesh Gandhi, who is known for his inspiring work on Right to Information. During the 26th session hosted by Anhad on the 9th of August 2019, the students of NMIMS Kirit. P Mehta were given a very useful and insightful information about Right to Information.

Mr Gandhi started the lecture by explaining the concept of 'Lokshahi'. He explained that Lokshahi is where each individual had the right by birth to feel as the 'badshah' 'begum' of the country. While explained bureaucracy and democracy, Mr. Gandhi rightfully pointed out the causes of inefficiency of the government citing the example of the frustration of the citizen over something as minor as the change in address in a ration card. While explaining the Freedom of Speech in Clause 19 (1) (a) engraved in the Constitution of India, the RTI activist gave a brief background on how the entire movement of RTI was introduced in India. Mr. Gandhi told us an inspiring story of Aruna Roy who pioneered the concept of RTI by introducing it in a small village in Rajasthan and led a protest against the government when it denied to provide information on the funds allocated for the people's welfare. Her belief was that if the money is being paid by her, then she was entitled to be aware at how it is being spent. Further, Mr. Gandhi explained the basic features of the RTI Act, stating that one should know the difference between interrogation and acquiring information. Mr. Gandhi provided us with an insight on the constitutional aspect of Article 19, specifically stressing on the Right to Know. Towards the end of the informative guest lecture, Mr. Gandhi acknowledged the Amendment of the RTI Act, giving a negative reaction towards the same, while addressing the fact that this move appears to be to gain control over the information commission and make the beholden to the government. The lecture concluded with a power quote from Mr. Shailesh Gandhi:

"Mera Bharat Mahan Nahi Hai, Par Yeh Dosh Mera Hai"


CENTRE FOR EXCELLENCE

KPMSOL Committees 2019 - 2020



CULTURAL COMMITTEE



What makes them unique is their constant effort to make sure that everyone goes back home with a lot more than they came with.


NMIMS STUDENT LAW REVIEW




PUBLICATIONS COMMITTEE
