**Refund Rules:** If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees\* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission

- In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount subject to maximum of Rs.5000/-

**Note : 1.** The above refund rules are subject to revision as applicable.

**1. Program:** Ph.D. in Law

## **2. Eligibility for Ph.D. in Law.:**

- Candidates for admission to the programme shall have a Master's degree in Law (LL.M.) or a professional degree declared equivalent to the Master's degree in Law (LL.M) by the corresponding statutory regulatory body, with at least **55% marks in aggregate** or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.

### **Note:**

- All students will have to complete Pre-Ph.D. course work. On successful completion of Pre-Ph.D. course work student will be registered for Ph.D.
- Those candidates who have obtained their degree by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply and register as per UGC guidelines.
- Candidates appearing or awaiting for final year result are also eligible to apply. Candidates are required to submit all mark sheet/s / certificates at the time of admission. & Masters (Qualifying) examination should have been conducted before the course commencement date.
- Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- Candidates are required to submit Graduation & Master's degree all mark sheets of all years, also AIU Certificate (University Equivalence) is mandatory for those candidates who have completed their graduation/post-graduation from Overseas Universities.

## **6. Selection Process:- Ph.D. in Law.**

The candidate must have passed Entrance Test conducted by the University.

**OR**

The candidate is qualified in UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/M.Phil. for Law examination of the apex bodies in higher/technical professional education or other equivalent examination.

**a) Entrance Test:**

1. 300 marks in total – each question carries 2 Marks - no negative marking
2. There will be total compulsory 150 questions only, in the form of MCQ and all need to be answered.
3. Paper 1 is common and compulsory for every candidate. Paper 1 will have 50 questions worth 100 marks. Paper 1 syllabus has 10 units and exactly 5 questions will be asked from each unit. Syllabus for Paper 1 is described below:

4. Paper 2 will have 100 questions worth 200 marks. Paper 2 syllabus has 10 units. Syllabus for Paper 2 is described below:

**Both the papers in the admission test component shall be held in the duration of 3 hours.**

**The candidate must have qualified entrance test with qualifying marks as 50% individually in both the papers as well as personal interview with 50 % marks conducted by the NMIMS University**

The ingredients of the units mentioned above and the level of examination in both the papers shall be at par with UGC NET examination.

**Note: Candidates those who have qualified in UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/ M.Phil. for Law examination of the apex bodies in higher/ technical professional education or other equivalent examinations with valid score in validity period are exempted from NMIMS entrance test. However, they have to appear for Personal Interview.**

**b) Personal Interview:**

- Power Point presentation based on Statement of Purpose (max 500 words) followed by Personal Interview.
- The candidates will have to discuss their research topic/interest area during Personal Interview (Research methodology and proposal for research).
- Final Selection will be on merit.

**7. Fees**

Fees for Batch 2022 was Rs. 2,50,000/- p.a. (for information only).

Fees for the current year 2023, will be intimated at the time of admission.

**Scholarship** are available to the deserving candidate at the time of admission. Scholarship form will be available on website (after declaration of merit list).

- Cancellation / withdrawal of admission:

Candidate has to upload cancellation form duly filled and signed along with fees paid receipt copy & cancelled cheque (personal account).

- Canvassing in any form will disqualify the candidate.
- Admission to program is considered as “Provisional Admission” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected/ admitted to the program
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her is incorrect, then application for the admission to the Program, even if selected and fees paid, will stand cancelled and fees will be forfeited.

### **Format for preparing SOP**

**Title:** The Title of the project should be concise (with sub-title, if any) reflecting the scope of the investigation.

**Aim of the Project:** The broad Aim of the project emphasizing the overall thrust of the proposed investigation should be clearly mentioned.

**Statement of the Problem:** The problem to be investigated should be clearly contextualized in the theoretical framework of the discipline.

**Overview of Literature:** The problem identified should be logically linked to other studies on the theme in the literature delineating the need for the present investigation.

**Conceptual Framework:** The concepts to be used, their relevance and applicability to the study and their operationalization should be indicated.

**Research Questions or Hypotheses:** The research questions to be answered/ addressed need to be unequivocally stated.

#### **Research Methodology:**

- (a) Coverage:** The proposal should clearly indicate the universe of the study, sampling frame, sampling methods, sampling size, units of observation etc.
- (b) Data Collection:** The proposal should indicate sources of data types of data, tools and techniques for collection of various categories of proposed data.
- (c) Data Analysis:** It should indicate the statistical techniques, if any, proposed to be used in data processing, specific packages for data analysis, content analysis, indices/scaling techniques proposed to be used etc.

**Implications:** The proposal should state whether this research would bring forth any implications for policy making either for the region concerned or the country, any methodological innovations or contribute to theory building.

**References:** The proposal should include a 'List of References' mentioned in the text along with other important recent additions to the literature on the theme. The references should indicate the author, title, publisher and year of publication.
